## PRODUCT APPLICATION

Rootella® F is intended for mixing with seeds in a planter box, it may also be applied in-furrow.

### Application rate - row crops

- Planter box (dry): 1.7 oz/ac (120 g/ha)
- In-furrow (dry, drip, in-line, or drench): 2.9 oz/ac (200 g/ha)

### Application rate - tubers, bulbs & vegetables

- In-furrow (dry, drip, in-line, or drench): 4.3 oz/ac (300 g/ha)

Application in liquid requires continuous agitation. Minimum filter size: 35 mesh (500 µm). Mix each 1 lb of Rootella® F with at least 10 gallons of water (>80 L/kg). Not to be used in proportional dosing pumps. Please contact us at support@rootella.com with any questions.
